EMBEDDED NETWORKS EXEMPTION CATEGORIES

Each Embedded Network that Active is responsible for operates under the applicable embedded network exemption codes in each state.

NSW & QUEENSLAND

Sites in NSW & Queensland are covered by the Australian Energy Regulator (AER) Exemption Guidelines. There is a guideline for a Network Exemption, which covers the electrical infrastructure and a guideline for the Retail Exemption which covers the retail sale of electricity.

Each Exemption Category has a series of conditions that Active must comply with in the operation of the embedded network. Copies of the Guidelines can be found on the AER website. You can also view an online list of all registered embedded networks on the AER website simply by typing your address into the search bar.

EXEMPTION CATEGORIES / CODES

For Retail, residential sites are registered under the Category Code R2 and commercial premises are registered under R1 and R5.

For Network, residential sites are registered under NR2, and commercial premises are registered under NR1 and NR5.

Some sites that are mixed use may be registered under all categories that are relevant.

VICTORIA

Sites in Victoria are covered by the Australian Energy Regulator (AER) Exemption Guidelines and the Essential Services Commission Victoria (ESC). The AER guideline for a Network Exemption, which covers the electrical infrastructure and the ESC guidelines for Network and Retail, which covers the sale of electricity.

For the AER Exemption Category there is a series of conditions that Active must comply with in the operation of the embedded network. Copies of the Guidelines can be found on the AER website. You can also view an online list of all registered embedded networks on the AER website simply by typing your address into the search bar.

The ESC has a series of categories of exemption, that closely mirror the AER requirements. You can search for your address at this <u>LINK</u>.

EXEMPTION CATEGORIES / CODES

For retail sales in Victoria, residential sites are registered under the Category Code VR2, and commercial premises are registered under VR1 and VR5.

For Network, residential sites are registered under the AER Code NR2, and commercial premises are registered under NR1 and NR5.

Some sites that are mixed use may be registered under all categories that are relevant.
